Pool: Eight Lane, 25 yard, with non-turbulent markers
The competitions course has not been certified in accordance with 104.2.2C (4).

Timing: Colorado Timing System with touch pads, and electronic scoreboard.

Special Note: There will be a continuous warm-up and warm-down lane available during the duration of the meet.

Awards: High Point Awards will be given to the top five male and female finishers in the following age-groups: 8 & Under, 9-10, 11-12, 13 and over. Hy-Tek Age Group Point System will be used. Priority for high point will go to swimmers competing in the IMX events (even if they are disqualified) over swimmers with a higher score who do not enter all the IMX events.

8 & Under*: 100 Free, 50 Fly, 100 Back, 50 Breaststroke, 100 IM

9-10 IMX Events: 200 IM, 200 Free, 100 Back, 100 Brst, 100 Fly

11-12 IMX Events: 200 IM, 500 free, 100 Back, 100 Breaststroke, 100 Fly

13 & Over IMX Events: 200 IM, 400 IM, 500 Free, 200 Back, 200 Brst, 200 FL

* Not an actual USA Swimming IMX category

“Best Time” ribbons for each time improvement for all swimmers. Time improvement will be based on entry time.

Rules: Current USA Rules will govern the procedure of the meet. Meet is pre-seeded, timed finals. The eight and under 25 yard events will be swam and scored to hand-held watches. The meet referee will be the final authority for the meet.

Eligibility: Open to all swimmers holding a 2010 USA Swimming membership card. Any swimmer that appears on the CSI exceptions report without registration must come to the meet prepared to show their card or they will be deck registered before they can enter the water. A surcharge of \$27.00 plus the normal registration fee for deck registrations. Age as of May 14, 2010 will determine swimmer's age for the meet.

Entries: The meet will be limited in swimmers to adhere to the 4 hour rule. Entries will be accepted in the order they were received. **Meet verification form must accompany entries.**

Entries may be sent using HY-TEK Meet Manager Disk and/or Commlink File by e-mail. Complete with all required information (name, team, USA number, time, age, and event number). Also be sure to include a hard copy printout of the team entry report.
